## Resolution #2

Whereas, soccer goalies are developing their skills and whereas a similar rule exists in community soccer and other SESAA sports

Moved {Steve Brugger (Green Timbers)/Mike Paulicelli (MB Sanford)} be it resolved that the current soccer rule dealing with goal kicks be amended to:

Opposing players must be on their side of the Retreat line. (Marked at the middle 3<sup>rd</sup>)

All opposing players cannot pursue the ball until:

- The ball is received by a teammate
- The ball travels over the line
- The ball leaves the field of play

Encroachment of retreat line:

If the defending team encroaches across the retreat line before an opposition player touches the ball, then the referee blows the play stopped and issues a re-take of the goal kick.

If the opposing team repeatedly infringes the retreat line, an indirect free kick shall be awarded from the place where the offence occurred for not respecting the restart.

- Carried, executive editorial amendment to make wording more clear

### **Resolution #3:**

Moved {Ryan Bolton (William Watson)/Tejpaul Mann (William Watson)} be it resolved that the current volleyball rule be amended to:

Only four players may play on the court at any one time.

- Ryan Bolton (William Watson): Wants 4 students on the court due to crowding and court size. Still able to have maximum participation for students as they can bring 17-20 players.
- \*Vanessa Wiebe (Cambridge)- Touches made in practice, game allows for flow into high school. More based on positioning and learning where to stand.
- \* Nadine Vandenberg – Time frame, will such a change last over the years?
- \*Voting- Total of 8 votes FOR, Opposed- Total of 20 AGAINST
- Defeated 20-8

### **Resolution #4**

Moved {Erik Henderson (Pacific Heights)/Sally Song (Pacific Heights)} be it resolved that the current volleyball rule be amended to:

Only five players may play on the court at any one time.

- Erik Henderson (Pacific Heights)- 6 on 6 many students stand around and watch the ball. 4 vs 4
- \* Hugh McDonald (Sunrise Ridge)- In favour of 4/5 students. Developmental stages for each sport, why not volleyball.
- \*Erik Henderson- Speaking with high school coaches. In favour of learning the skills rather than focusing on positioning
- \*Ryan Bolton (William Watson)- Setting a plan for this for the next few years to make sure we can keep this plan in action. It is confusing for children and they are not able to practice proper ethics.

## 2019 – 2020 BUDGET/TREASURER’S REPORT

### District Funding and Support:

The district continues to pay for some release time for those coordinating events. The district also pays for supplying championship material such as wristbands, rosettes, and ribbons for our playdays and events. We continue to be supported by our district and we are thankful for their financial involvement.

### SESAA Account:

Our bank account continues to be in a healthy position (as shown below). This account is funded by the annual school levy of \$100.00 per school. We use this account to cover release time for event coordination, coaching recognition awards, AGM expenses, and on-going expenses such as starter caps and equipment for track meets and other sports that require additional equipment to operate. The balance currently seems high, however, a large portion of our budget usually allocated to AGM costs will go unspent this year due to the COVID-19 situation.

We try and keep a healthy balance of at least \$5,000.00 from year to year. This balance will be used when emergencies arise which might include: needing more release days, purchasing equipment for sports, buying additional bracelets, etc.

### Motion for School Levy 2020-2021

The school athletic levy continues at \$10,100.00 for the 2020-2021 school year.

### 1. ORGANIZATIONAL MEETINGS:

There was an organizational/planning meeting held on Thursday, Sept. 12, 2019 at Lena Shaw Elementary. As is usually the case, most information was sent out via email, but about 8-10 coaches attended the meeting to set up games and clarify uncertainties (about rules, scheduling, etc.). Among items discussed was the new retreat line rule and playday parameters.

### 2. ZONE PLAY REPORT/FINAL RESULTS:

Coaches registered their teams through a google form I sent out via email to PE contacts and last year's coaches. I compiled the list of teams and coaches for each school and organized them into zones (to help coaches set up games with their surrounding schools).

The majority of schools had no problem establishing their own games and most had 2-3 before their play-days. Some asked about a schedule and/or having zone representatives, but based on how long it took teams to register and how short the soccer season is, I don't know if that would work. Most coaches continue to find the email list useful.

There were 35 Boys "A" (a small increase from 34 last year), 15 Girls "A" (a small increase from 14 last year), 3 Boys "B" (the same as last year), and 17 Co-Ed (a small increase from 16 last year) teams that participated in 17 different play-days. In total, over 1 000 students played soccer this fall.

Schools were divided into small tournaments of 3, 4, or 5 teams based on location (and in some cases school size). All teams played each other once and most tournaments had time for a game between the top two teams. Bracelets were awarded to all teams based on their placement at their playday. Coaches or parents volunteered to referee games.

Schools with good grass/turf fields were asked or volunteered to serve as hosts. In 7 cases, Surrey Parks turf fields were used only until 3:00 (Newton Athletic, South Surrey Athletic, Hjorth Park, and Cloverdale Athletic), which helped to cut costs. Renee Gregerson assisted in booking Surrey Parks fields and in ensuring that all school fields were safe and lined prior to play-days.

Weather did not end up being a major issue this year, as it has in the past. All play-days were able to go ahead as planned.

### 3. BUDGET:

Bracelets – refer to PE clerk who placed order.

### 4. RECOMMENDATIONS FOR NEXT YEAR:

- Bracelets orders were placed in advance by Sean Juteau in the past and this allowed them to arrive just in time to reach host schools. Since we are moving this responsibility back to the convenor, I will make sure there is enough bracelets to be distributed for next school year by the spring time.
- Deciding whether we are still doing 1<sup>st</sup> place rosettes so I can place an order this spring for next school year.
- Continue to use Google Forms to collect registration information.

- Continue to keep the number of teams at each tournament at 3 or 4 (unless side-by-side city fields can be booked).
- If possible encourage schools to have their teams finalized before the final playday schedule comes out. We still had some revisions after the final schedule was released (some changes were unavoidable) causing a lot of last-minute switches for host schools.
- One coach has talked to me about using red and yellow cards for game play at the playday tournaments. I recommended that this be brought up to the executive and possibly the AGM for discussion.

#### **5. SEASONAL DATES FOR NEXT YEAR:**

The organizational meeting should be hosted on Thursday Sept 17, 2020 at Lena Shaw (second Thursday of school like last year). Playdays should take place October 12-16, 2020 (6<sup>th</sup> week of school like last year). Can I also request that registration be closed Friday September 18, 2020 and that date added to next year's SESAA calendar?

### 1. ORGANIZATIONAL MEETINGS:

The league registration was completed using Outlook email. Beginning February 4<sup>th</sup> and continuing through February 14<sup>th</sup>, coaches and contacts registered their teams for either Grade 7 league play, or Grade 5/6 league play. Interested coaches were offered a workshop on February 11<sup>th</sup> to assist in the preparation of their season. The workshop was attended by 10 coaches and consisted of 90 minutes of drills and technical discussions of rules and regular operating procedures.

### 2. ZONE PLAY REPORT/FINAL RESULTS:

The badminton teams were scheduled to begin league play March 3<sup>rd</sup> for grade 5/6, and March 5<sup>th</sup> for grade 7. There were 72 schools registered in the grade 7 league, and 41 schools registered in the grade 5/6 league. This number represents an eight percent decrease in the number of teams participating from the previous year. Assuming an average of 20 students per team, the participation in badminton this year was estimated to be approximately 2260 students, with all zones represented.

Due to extenuating circumstances, the season was postponed after week two, and officially cancelled at the conclusion of the regular season. Playday was scheduled, but not implemented.

### 3. BUDGET:

As orders were not officially placed, this year the budget for wristbands and rosettes was 0\$. The budget recommendation for 2020-2021 is to maintain the budget at \$700.00 for wristbands and rosettes, and a release day for the convenor.
